Richard Reynolds, Jr., and Elizabeth Williams Family Timeline

Abt 1659        Isle of Wight Co., VA.    Richard Reynolds (Jr.) was born to Christopher Reynolds and Elizabeth Sharpe.    (Richard Reynolds, Sr., was the uncle of Richard Reynolds, Jr.)

Abt 1660        Isle of Wight Co., VA.    Elizabeth Williams was born to George Williams, Sr., and unknown Boucher.

10 Apr 1671    Isle of Wight Co., VA.    George Williams, tailor, was deeded 100 acres of land by Pharoah Cobb and his wife Anne. This land later was left by George Williams to his eldest son William Williams. The land then passed to the brother of William Williams, George Williams II and the same sold it 06 April 1700 to Richard Reynolds, Jr. who had married Elizabeth Williams daughter of George Williams I.[1]

By 1685        Isle of Wight Co., VA.    Richard Reynolds married Elizabeth Williams, daughter of George Williams (Sr.).[2]

ca Apr 1685    Isle of Wight Co., VA.    "Richard Reynolds Jr. and wife Elizabeth and brother-in-law George Williams, orphan of George Williams, receive the estate of William Williams, decd. Pharaoh Cobb to produce the will.[3] 'Estate' meant personal property, most likely livestock and household goods in this case. We know most of this information from later records, the main significance of this one being that it tells us Richard Reynolds the younger was married to Elizabeth Williams by 1685, thus explaining the following record for February 1686."

9 Feb 1685/6    Isle of Wight Co., VA.    [The following is verbatim from the excellent analyses of Robert W. Baird, www.genfiles.com, "Bob's Genealogy Filing Cabinet," pdf on "Isle of Wight County Records - 1622-1699," p. 20.] "Deed: Richard Reynolds to William Murfrey, both of Isle of Wight, no compensation noted, 100 acres in the lower parish (being land conveyed by Richard Webb to Richard Gadsbey and now in the occupation of said William Murfrey)...wherefor was required thereunto as for Eliza. my wife". Witness: John Nevill and Robert Driver. Signed: Richard Reynolds, Eliza. (x) Reynolds. Recorded 9 Feb 1685/6 on oath of Richard and Eliza his wife. [Isle of Wight Deed Book 1, p216]

"This is clearly Richard Reynolds the younger. The land is evidently his wife's from her father's estate. Ten years later when Murphrey sold the land, he described it as half of a 200-acre parcel adjoining Thomas Bombridge deceased, John Askew and the Meadow Swamp. Meadow Swamp seems to be what is now called Cohoon Swamp, several miles south of Cypress Creek.

"An interesting connection: I can find no patent to Richard Webb, but there is a later deed by John Askew's heir, and witnessed by Murfrey's grantee, which refers to "Richard Webb's land originally taken up by Richard Staples" bordering the Meadow Swamp. The land Richard Reynolds is selling to William Murfrey is evidently quite near this land, or perhaps part of it. That raises the question of whether there was some relationship between Richard Staples and George Williams."

09 Aug 1695    Isle of Wight Co., VA. [Malachi] Hawley appoints Charles Chapman as his attorney in the suit with Mr. Robert Coleman. Witness: John Williams and Richard Reynolds. [Isle of Wight Deed Book 1, p167 abstracted by Hopkins][5]

08 Jun 1698    Isle of Wight Co., VA.    Rich. Reynolds, Sr., of L. Par. sells to Richard Reynolds, Jr., for 13,000 lbs. tbc. a tract of land part of a pat. of 380 acres Apl. 1681 in occupation of Edward Goodson, Wm. West, John Tyler and Richd. Reynolds, Sr.    Francis Floyd, John Butler.[6] Richard Reynolds, Sr., was the uncle of Richard Reynolds, Jr.

09 Jun 1698    Isle of Wight Co., VA.    Richard Reynolds, Jr., sells 100 acres to Richard Reynolds, Sr.    Wit.: Francis Floyd, John (X) Rutter, Richd. (X) Wooten.[7]

15 Jan 1699/1700 Isle of Wight Co., VA.    Will of Richard Sharpe: Legatees - Anne Harris in case she recovers from the present sickness, cousin Richard the son of my cousin Richard Reynolds the full term of my lease from Col. Arthur Smith, Christopher and Sharpe Reynolds the sons of my cousin Richard Reynolds. Executor: Richard Reynolds. Recorded 9 April 1700.[8]    A different record identifies the executor as Richard Reynolds Jr.[9]

06 Apr 1700    Isle of Wight Co., VA.    George Williams [Jr.] sells to Richard Reynolds, Jr., and Elizabeth, his wife, for 4000 lbs. tbc., 100 acres land in L. P. (Lower Parish) contained in a deed, 10 Apr. 1671, made by Pharaoh Cob and Anne, his wife, to George Williams, father of the aforesaid George Williams; which land descended to Wm. Williams, elder brother of the first named George Williams, who is dead, and from said Williams did descend unto the first named George Williams-Land in occupation of Mathew Lowry, 6 April 1700.    Ar. Smith, Thomas Smith, Math. Lowry.[10]

28 Jul 1707    Isle of Wight Co., VA.    Christopher Reynolds of the Lower Parish sold to Timothy Tynes of the same place, 100 acres in the said parish (being land formerly bought by my father, Richard Reynolds, from Richard Reynolds, Jr., on 9 Jun 1698, and my father lately dyeing descended to me) bounded by Arthur Smith and Giles Dryue (Driver.) Witnesses: Arthur Smith, John Frissell, Thomas Summersoll, recorded 09 Aug 1707, signed by Christopher, Joyce, and Elizabeth Reynolds.[11]

27 Jul 1711    Isle of Wight Co., VA.    Richard Reynolds of the Parish of Newport made his will.    Leg.-wife Elizabeth, son Richard, son Sharpe, son Christopher the land on which Richard Jackson lives; land on which Edward Griffith lives, to Richard Jackson; grandson \_\_\_\_Reynolds; what is due Elizabeth Lewis, one of the daughters of Richard Lewis to be paid.    Executors: My wife and sons.    Wit.: A. Smith, Giles Driver, Jane Benn.[12]
